Opening Session

Jan Danckaert is the current Rector of VUB, Brussels and the president of the Flemish Interuniversity Council. He is Professor of Physics and Photonics at the Sciences, Engineering and Bio-Engineering Faculty, with a PhD on nonlinear optics and expertise in semiconductor laser dynamics and nonlinear dynamics. He is co-founder and head of the interdisciplinary Applied Physics research group (APHY), which studies complex systems in different fields of science and technology. As Vice-Rector of Education and Student Policy, he successfully guided VUB through its institutional review during the pandemic, consolidating its position as a university engaged for Brussels and society, while also being committed to blended learning and the integration of face-to-face and online education.

Pia Ahrenkilde Hansen is the Director General of the Directorate-General for Education, Culture, Youth and Sport at the European Commission. She took up this position on 16 September 2023, after holding the same position for four and a half years in the Commission's Directorate-General for Communication. From March 2018, she served as Deputy Secretary General and Chief Operating Officer. Prior to that, she was also Director in the Directorate-General for Communication, in charge of the Commission's Representations in the Member States. Between 2009 and 2014 she was Chief Spokeswoman of the European Commission; and Deputy Spokeswoman of the European Commission from 2004 until 2009 under former Commission President Barroso, also in charge of Planning and Coordination of the Spokespersons' Service (SPP). She began her career in political communication as Environment Spokeswoman in 1999 (Commissioner Margot Wallström), having previously held positions in the Commission's departments for Industry (1995-97) and Information, Communication and Culture (1997-99). Pia Ahrenkilde Hansen was a Schuman Scholar at the European Parliament (1989-90). She studied Business Administration and Modern Languages at the Copenhagen Business School and Political Science at the Institut d'études Politiques de Paris, specialising in intercultural communication and European identity

Caroline Gennez is Belgium's Federal Minister of Development Cooperation and Major Cities. She was a member of the Parliament of Flanders and President of the Flemish Socialist Party. She wrote a social manifesto for the Party of European Socialists on the political economy, social justice and the fight against inequality and published a book on social engagement, "De verschilligen". She has a Master's Degree in Social and Political Sciences and was Chairwoman of the University Association of Brussels.

Tom De Smedt is deputy head of the Belgian Representation to the European Commission. Before he worked for various policy domains in the European institutions, dealing with strategy and communication on regional and health policies, civil protection and humanitarian aid. Before joining the EU institutions, he worked as an advisor for the Government of Flanders, and for many years as Head of Communications at Ghent University. At the latter, he also taught in the Master's program on communication management. He studied social sciences, media studies and business communication at the Universities of Ghent and Barcelona.

Chairs

Ann Peeters is the Vice-President of the Council for International Policy at VUB (Vrije Universiteit Brussel) and member of the Bureau of VLIR-UOS. She is an Associate Professor at the Department of Linguistics and Literary Studies, with a joint PhD degree in Italian Literature awarded by VUB and the Università di Pisa (2013) on intertextual relations between Alessandro Manzoni's novel *I Promessi sposi* and the various opera adaptations and a MA in Romance Languages (French – Italian). She co-organized conferences on life writing, intermediality and the narrative potential of music. Her teaching assignment includes courses on Italian literature and culture as well as on multilingualism, multilingual literature intertextuality, intermediality. Her current research interests focus on intertextuality, intermediality, multilingualism in higher education and multilingual pedagogies. In 2023, she was awarded an honorary doctorate from the University of Lubumbashi.

Benoît Raucant is the academic director of the Circle U. Teaching and Innovations Lab (CU.til) and Professor at the Polytechnic School of Louvain (UCLouvain). In 2000, he coordinated a major reform in the engineering school to promote problem-based and project-based learning. Since 2015 he has been the head of the Louvain Learning Lab (center for teaching and learning) which supports teachers in their professional development and innovations. He also contributes to training teachers in active pedagogies in several universities. He is the coordinator of the "LLL guide" collection.

Fanny Meunier is the current academic director of Circle U.'s Multilingualism, Interculturality and Language Lab (CU.mil) and is Professor of English Language, Linguistics and Teacher Education at UCLouvain. Her research interests and publications cover fundamental, applied and instructed Second Language Acquisition. She has been involved in numerous international research projects. Her most recent projects focus on multi- and plurilingualism in the digital era.

Jo Angouri is Professor in Sociolinguistics and Deputy Pro-Vice Chancellor for Education and Internationalization at the University of Warwick, UK, a Visiting Distinguished Professor at Aalto University, School of Business, Finland, Affiliate (Visiting Professor) at Monash University and holds the Lonnoy Chair for Multilingualism at Vrije Universiteit Brussel in Belgium. Jo is on The EUTOPIA University Alliance Education Team and is co-leading the Learning Communities and Curriculum Development for the network. She has published extensively on Leadership, Identity, Multilingualism, Decision Making and Problem Solving as well as on Research Methodology. Her work addresses language policy and language practice (and the implications of disconnection between the two); the trajectories to and from linguistic, geographical, and spatial centers to multiple peripheries and back again as well as the opportunities/consequences for individuals to remain at the periphery, or the barriers that keep them there. Her current work looks into transnational education, education policy and multilingual pedagogies.

Laurence Mettwie is professor of Dutch Language and Linguistics at the Université de Namur (Belgium). Her research focuses on societal aspects of multilingualism, multilingual education and emotional and socio-affective factors involved in Second Language Acquisition.

An Van linden is Associate Professor of English Language and Linguistics at the University of Liège. Her research focuses on (semi-) independent subordination patterns and modal-evaluative expressions. In addition, An is documenting and describing Harakmbut, an unclassified language from the Peruvian Amazon.

Cosmobility: Rethinking Student and Staff Mobility

Chair

Anne Weyembergh is the Vice-Rector for External Relations and Cooperation at ULB. She has been President of the Institute for European Studies of the ULB since October 2014. In addition, she is the coordinator of the team on European criminal law (Centre for European Law). Her main research activities relate to EU criminal law (police cooperation and judicial cooperation in criminal matters) but also criminal law in other legal orders (national and international law) and European law more broadly, with a special focus on the area of freedom, security and justice.

Professor Pagèze teaches scientific English and specializes in innovative practices in language learning, multimedia tools and scientific communication. She explored different teaching and learning methods in multilingual and multicultural classes and set up a pedagogical and linguistic support system for teaching English as an accompaniment in international Master programs. Awarded the "Passion Enseignement et Pédagogie dans le Supérieur" prize in 2017, she supported the development of inclusive and accessible internationalization, also embracing new opportunities for hybrid or distance collaborations.

She focusses on inclusive education, differentiated instruction and blended learning.

Susanne Feiel is Director International Relations and European University at the Montanuniversität Leoben in Austria and head of the Resources Innovation Center, part of the EIT RawMaterials, EIT Climate-KIC, SDG and sustainability actions. She is a Doctor of Engineering.
